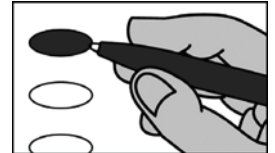

If you want to change a vote, or if you have made a mistake, ask an election worker for another ballot.

If you make marks besides filling the oval, your votes may not count.
