

## February 14, 2018 Electoral Board Meeting

The regular monthly meeting of the York County Electoral Board was called to order on Tuesday, February 14, 2018, at 10:02 a.m. by Chairman Richard Rawls. Others present were: Phillip Wolf, Vice-Chairman; Sandy Molineaux, Secretary; and Walt Latham, Registrar.

The August minutes were read and approved. Minutes taken in the absence of Secretary Molineaux will be presented for approval at the March meeting.

Registrar Latham reports scanning of registration forms has been completed. All registration forms are now on line. There is a question as to where the hard copies should be stored.

A copy of the FY 2018 budget will be given to the Board and a copy of the FY 219 budget will be forwarded to the Board as soon as possible.

The County Budget Department has asked the registrar to open a business account at Sam's Club where we can use our tax free status.

Walt Latham continues to work with County Administration on getting more work space. Our work space availability is shrinking rather than increasing. Vice-Chairman Philip Wolf suggested inviting the County Administrator to each meeting.

The Board voted on 108 applicants for election official status. All were accepted. Their terms will run from March 1, 2018, to February 28, 2019.
