

## **November 7, 2020 Electoral Board General Election Canvass**

The canvass was called to order Saturday, November 7, 2020, at 12:04 p.m. by Chairman Richard Rawls. Others present were Vice-Chairman, Phillip Wolf; Secretary, Sandy Molineaux; and General Registrar, Walt Latham. . Also present representing the York Poquoson Democratic Committee was LeRoyce Bratsveen.

A DS200 was set up to vote the accepted provisional ballots. The seal (#451598) was broken. Forty eight non absentee ballots were identified.

(Closed Session)

At 12:16 p.m. Chairman Rawls moved to go into closed session to further review provisional ballots.

(Open Session)

At 2:28 p.m. Secretary Molineaux moved to return to open meeting session for a break. The motion was approved by a unanimous voice vote.
