2022 Tax Relief Deadline Approaching

York County offers a program for taxpayers who are age 65 or older or permanently disabled. Tax Relief for the Elderly and Disabled exempts, or partially exempts, the tax on their real estate or mobile home. An application must be filed with the Commissioner of the Revenue, annually, by **April 1**. Read more details and find an application [here](#). There is also a tax exemption on real property for qualified veterans that are 100% service-connected, permanent and totally disabled, or surviving spouse **due April 1**. 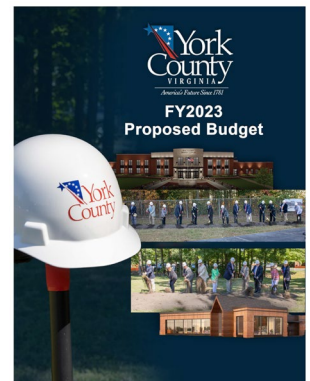
The Commissioner of Social Services Comes To York County

This is the budget that will begin July 1, 2022 and run through June 30, 2023. Morgan shared the budget drivers and priorities but also cautioned that changes may occur depending on any General Assembly actions (i.e. grocery sales tax).
