The Treasurer only collects taxes, does not assess property, fix valuations, set rates, or grant exemptions, and has no authority to make changes on the tax roll. A 2% late penalty plus interest of 6% per annum will be added after the **original due date**. Penalty and interest are calculated separately for each item.

#### PAYMENT INFORMATION

- Payments received from a bank's online banking service must be received in the Treasurer's Office by the due date. Contact
  your bank to determine the required processing time. To assure proper posting please use the correct account number for each
  payment. Providing incorrect information may result in late payment charges.
- Authorization for Electronic Debit: When you provide a check as payment, you authorize us to process the payment as a check
  transaction or use information from your check to make a one-time electronic fund transfer from your account. When we use
  information from your check to make an electronic fund transfer, funds may be withdrawn from your account as soon as the
  same day we receive your payment, and you will not receive your check back from your financial institution.
- Payments received with late postmark will be assessed late penalty and interest.
- All monies received will be applied to the oldest taxes due.
- ALL York County property owners, including properties that have a mortgage company escrow to pay the taxes, receive real
  estate bills. If a mortgage company is responsible for payment of taxes, the bill is for your records only. Citizens responsible for
  paying their own real estate taxes should remit payment by the due date on the bill.

## Tax Relief for the Elderly or Disabled Program

-Qualifying Criteria:

Elderly: Age 65 or older on December 31st of the previous tax year

Disabled: Permanently and totally disabled on December 31st of the previous tax year (certification required)

- -May qualify for a total or partial exemption of real estate taxes if applicant meets eligibility requirements.
- -Dwelling and up to 10 acres of land, occupied as the sole residence of the owner (if jointly owned, only one has to qualify).
- -Limitation on total income and financial worth or assets as established by local ordinance.
- -To be eligible, an application must be filed **EACH** year.

## **Veteran Exemption**

- -100% service-connected, permanent and total disability
- -Includes property that is owned jointly by the husband and wife
- -Dwelling and up to 10 acres of land and occupied as the primary residence
- -A copy of the documentation from the Department of Veterans Services must be provided
- -Initial application required
- -Effective as of January 1, 2011
