

In 2024, we had a brand-new strategic plan, developed by our [Board of Directors](#), to guide us and to hold us accountable for specific outcomes. As part of the process, we identified three main lines of effort that defined the work that we do and the value that we intend to bring to our members and our community. We had significant success in each of these areas: **Leadership Development, Collaboration** and **Advocacy**. Our efforts were outlined by

the plan and guided by the following Board committees: **Governance, Membership, Leadership, Business Education, Public Policy, Finance, Marketing** and **Military Affairs**. Here are just some quick data points that help to demonstrate our success in a tangible way:

- We welcomed **143 new member businesses**
- Our **retention rate** was **88%**
- We held **119 events** and had over **10,000 registered guests**
- We celebrated the **40th Anniversary of our LEAD Peninsula** program and graduated 45 participants
- We introduced two new significant “State of” events, the **State of the Federal Labs** and the **State of the Military**
- We hosted three more **Rising Tide events**
- We created and introduced an Advanced Leadership Development course, **LEAD Higher**, in partnership with **Christopher Newport University**
- We re-imagined, restructured and renamed our Bi-weekly Newsletter, now called ***The Catalyst*** (you’re reading it right now)
- We expanded our **Public Policy Advocacy** efforts at the local, state and federal levels


### *VPC Executive Committee*

## **Local Government Update**

The Virginia Peninsula Chamber of Commerce has finalized its 2025 Legislative Priorities, reflecting the collective insights of chamber members, the Public Policy Committee, the Board of Directors, and key community stakeholders. These priorities, which were shaped through three collaborative roundtables and validated during our recent legislative meet-and-greet, set a clear agenda for the upcoming “short” session of the General Assembly, beginning January 8, 2025. Here is a summary of our most important positions, and a copy of our complete 2025 legislative agenda...





On Wednesday, November 13, 2024 the LEAD Peninsula Class of 2025 held their **History, Hospitality, and Tourism Day**. The day began at [Fort Monroe's Visitor and Education Center](#) with a presentation by Acting CEO, John Hutcheson, and a representative from the [National Park Services](#). Following the presentations, Dr. Françoise Bonnell and members of her team gave the group a guided Casemate tour.

The next stop of the day was the [Hampton Virginia Aquaplex](#); where the group received a tour of the facility, led by General Manager, Todd Fizer. Following the tour, Jay Richardson, Senior Group Sales Manager for Sports at the [Hampton Convention and Visitor Bureau](#) gave a presentation on the impacts of Sports Tourism on the Peninsula, region, and beyond. Here the class also heard from Mary Fugere, Director of the Hampton Convention and Visitors

Bureau and Hampton Marketing Outreach, on the [Coastal Virginia Tourism Alliance](#) and [VA250](#).

To close the session, the group heard from Rebecca Kleinhample, Executive Director of the [Virginia Living Musuem](#), who shared the unique founding of the Museum and the current exciting growth phase. Katie Begley, Advancement Director, provided the class with a "sneak peek" tour of the new "[Wild Care Center](#)" Veterinary Hospital and Nutrition Center. There the group learned about the care of over 900 native species on campus and educational programs that serve over 32,000 students each year. Special guests included Lyn Heller, Senior Director, Living Exhibits and a few "Animal Ambassadors".






