**\*\*\*Architect, Engineer or Land Surveying\*\*\***

Effective July 1, 2011, no locality shall issue or renew a local business license unless the architect, engineer or land surveying furnishes proof of compliance with licensure or certification by the Virginia Department of Professional and Occupational Regulation or provide an affidavit of exemption; in accordance with the Code of Virginia § 54.1-406.

- Unless exempted by § [54.1-401](#), [54.1-402](#), or [54.1-402.1](#), a person shall hold a valid license prior to engaging in the practice of architecture or engineering which includes design, consultation, evaluation or analysis and involves proposed or existing improvements to real property.
- Unless exempted by § [54.1-401](#), [54.1-402](#), or [54.1-402.1](#), a person shall hold a valid license prior to engaging in the practice of land surveying.
- Unless exempted by § [54.1-402](#), any person, partnership, corporation or other entity offering to practice architecture, engineering, or land surveying without being registered or licensed in accordance with the provisions of this chapter, shall be subject to the provisions of § [54.1-111](#) of this title.

**Architect, Engineer or Land Surveyor - Affidavit of EXEMPTION from the provisions of this chapter**
