Artists are invited to submit their work to participate in Yorktown's fourth annual **Art at the River** juried art show on Sunday, May 7, 2017, from 10AM to 4PM to be held on Chiskiack Green, Riverwalk Landing, Water Street, Yorktown, VA.

Yorktown is located on the banks of the York River, part of Virginia's Historic Triangle of Williamsburg, Jamestown, and Yorktown.

Set-up for **Art at the River** will be on Sunday between 7 and 9AM. Artists must provide a 10x10 tent and tables/racks necessary to display art. Show will be open to the public from 10AM to 4PM.

Award winning pencil & charcoal artist and teacher, Mary Lee Ruff, and renowned glass artist and teacher, Ali Rogan, will judge the works of art between 10AM and 12 NOON. Prizes totaling over \$3,000 will be awarded.

A special exhibit of juried art by students from York County high schools will be held in the Freight Shed, from 10AM to 4PM.

1<sup>st</sup> Place and Best in Show winners of the 2016 **Art at the River** show will be exempt from the jury process and the application fee; however, must submit an application form and images.

**ELIGIBLE WORKS**

All works must be original creations of the artist in the following categories:

**Watercolors, Oils, Acrylics, Tempera, Pen & Ink Drawings, Pastels, etc**

**Photography** – All images must be shot by the artist; prints must be signed and numbered.

**Woodwork, Pottery, Glass, Metalwork, Fabric Art, Jewelry, etc.** All ceramics, glass, jewelry, or metal pieces must be hand built, thrown, blown, cut, strung, cast, fused or otherwise created by the artist. Jewelry components must feature handmade beads or natural stones. No form of mass production is permitted.

**ACCEPTABLE TO SHOW:** Original works in clay, glass, fiber, metal, basketry, leather, jewelry, wood, graphics, photography, musical instruments, and mixed media. All artwork must be conceived and executed solely by the exhibiting artist. All artwork must be for sale. **All artists must be present during the entire show.**

**UNACCEPTABLE TO SHOW:** Shell crafts, decoupage and decal crafts; works made using commercial molds or kits; dried flower arrangements; and works utilizing materials from endangered species; commercial or mass-produced items. **Sales persons and/or agents hired to operate booths are not acceptable.**

**SPACE FEES - \$125 regular 10x10 space  
\$150 corner/end 10x10 space**

The Space Fee will be due upon acceptance into the Show. **No tent sharing will be allowed.** Space assignments will be on a "first-paid" basis. Notification of space location will be provided prior to the event.
